VACANCY CIRCULAR

Subject: Filling up of two vacancies of Proof Reader in the Legislative Department, Ministry of Law & Justice on Deputation/Absorption basis.

It is proposed to fill up two vacancies (one vacancy by deputation and other vacancy by deputation/absorption) of Proof Reader in the Legislative Department, Ministry of Law & Justice in Level 5 (Rs.29,200-92,300/-) in the Pay Matrix. The post belongs to General Central Service, Group "C" (Non-Gazetted, Ministerial post).

2. The eligibility criteria for the posts are as under:

Persons working in similar or equivalent grade on regular basis in the Central Government Offices or Government Presses and possessing educational and other qualifications as under:

Essential:

- i. A Degree of a recognized University incorporated by or under a Central Act: Provincial Act or a State Act or any institution for higher education deemed to be a University by the Central Government or any other institution or foreign University approved by the Central Government.
- ii. Minimum five years' experience of Printing work in English in the Ministry of Law and Justice and /or any Central Government or a State Government Press or any other Press or a Newspaper office.
- iii. Should qualify in a departmental test in English Proof Reading.

Desirable:

A degree in Law of a recognized University.


Note 1: The departmental officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment by promotion.

Note 2: Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization or Department of the Central Government shall ordinarily not exceed three years. The maximum age-limit for appointment by deputation shall be not exceeding 56 years as on the closing date of receipt of applications.
